Class I Shares (EUR Accumulation Shares) LU1917706332, a sub-fund of Columbia Threadneedle (Lux) III (the "Company"), regulated by the CSSF.

This Fund is managed by Threadneedle Management Luxembourg S.A. (the "Manager")

Objectives and Investment Policy

- The objective is to achieve long term capital growth and support sustainable development.
- The Fund seeks to achieve this by investing in a spread of equities and equity related securities such as warrants (the right to purchase a security, at a specific price within a specific time frame) of mid-capitalisation companies, anywhere in the world, including emerging markets, and in any industry or sector.
- The Fund will invest in companies identified through reference to the seventeen United Nations Sustainable Development Goals (SDGs), which address issues including poverty, inequality, climate change, environmental degradation, prosperity, peace, and justice. The Fund may enter into financial futures contracts (including equity index, interest rate and currency futures contracts), if in the opinion of the Manager, such contracts will protect the value of the Fund's assets from adverse movements in equity markets, interest rates or currency exchange rates. Such investments will only be used for hedging purposes or efficient portfolio management.
- The Fund is actively managed in reference to the MSCI ACWI MID Cap NR Index. The index is broadly representative of the securities in which the Fund invests, and provides a suitable comparator benchmark against which Fund performance will be measured and evaluated over time.
- The fund manager has discretion to select investments with weightings different to the index, and that are not in the index, and the Fund may display significant divergence from the index.
- Income from investments in the Fund will be added to the value of your shares.
- You can buy or sell shares in the Fund on any day which is a business day in Luxembourg and London. You can find more detail on the investment objective and policy of the Fund in the Prospectus. - Recommendation: this fund may not be appropriate for investors who plan to withdraw their money within 5 years.

Risk and Reward Profile

The Risk and Reward Indicator table demonstrates where the Fund ranks in terms of its potential risk and reward. The higher the rank the greater the potential reward but the greater the risk of losing money. It is based on past data, may change over time and may not be a reliable indication of the future risk profile of the Fund. - The Fund is rated 5 because historically it has shown a medium to high level of volatility (how much the value of the Fund goes up and down).
- The lowest category does not mean a risk-free investment.
- The indicator may not necessarily take into account the following risks:
 - Market Risk: the value of assets held by the Fund may go down as well as up. There can be no assurances that the investment objectives of the Fund will be achieved.
 - Restricted Diversification: investments are concentrated in companies which are focused in a specified number of areas. These investments are limited to a narrower segment of global stock markets and this may mean the Fund is more sensitive to price swings than a fund that is not focused on the SDGs.
 - Currency Risk: your investment may be adversely affected by changes in currency exchange rates.
 - Counterparty Risk: to gain greater income the Fund may deposit cash with various approved Counterparties. Return of the cash is dependent upon the continued solvency of the Counterparty.
 - Warrant Risk: small movements in the price of the asset to which the warrant relates may result in a disproportionately large movement, up or down, in the price of the warrant.
- The risks currently identified as applying to the Fund are set out in the "Risk Factors" section of the Prospectus.

Charges

The charges you pay are used to pay the costs of running the Fund, including the costs of marketing and distributing it. These charges reduce the potential growth of your investment.

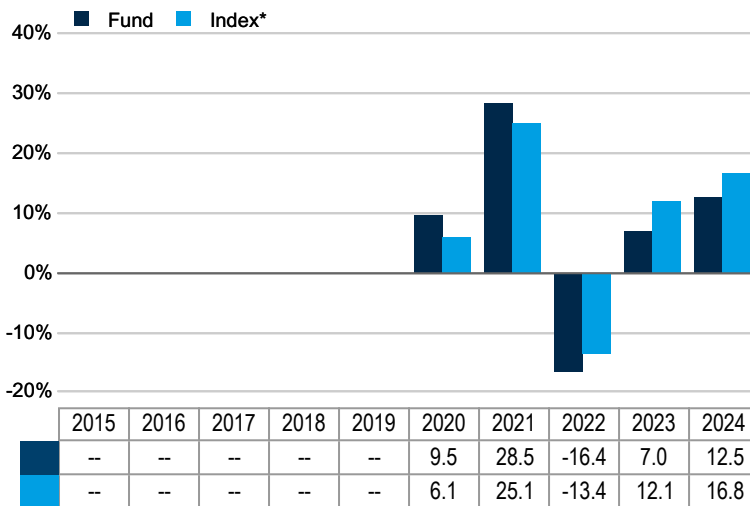
