Fund objective and policy

The Fund aims to provide income combined with capital growth over the long term (at least 5 years). The Fund seeks to achieve this by combining a core equity component with an active derivative strategy to enhance income. The Fund is actively managed. It is not constrained by its comparator benchmark, MSCI All Country World NR Index and invests primarily in shares of companies located anywhere in the world, be of any size and from any industry or economic sector, subject to the Fund's sustainable investment criteria. The Manager seeks to avoid investments in companies with damaging or unsustainable business practices; invest in companies providing solutions to sustainability challenges or making positive contributions to society and/or the environment; and improve investee companies. ESG practices through proactive and constructive engagement and voting.

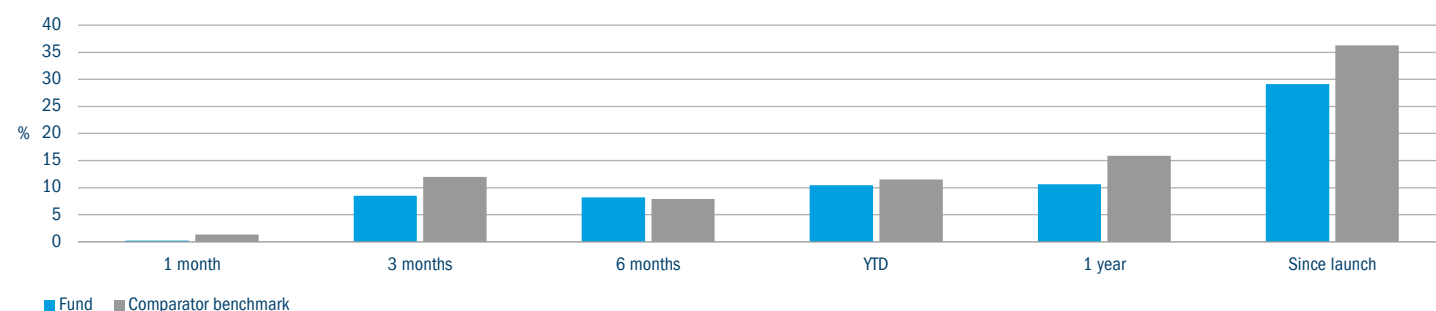
