Fund objective and policy

The objective of the Fund is to achieve a long-term capital appreciation. The Fund mainly invests 'long' (purchasing) and 'short' (selling) in equities of companies predominantly involved in real estate and related activities. Investments will be predominantly in companies that are domiciled in or derive a substantial proportion of their revenue from Europe, although investment outside of Europe including emerging markets is permitted. The Fund may also invest in other investments such as convertible bonds and fixed income securities. The Fund will use derivatives to 'short' and maintain, increase or reduce exposure to particular investments or a relevant market index for investment and for hedging purposes. For the purposes of calculating the performance fee, the Fund references the Euro Short-Term Rate (€STR) or the equivalent currency-specific benchmark for share classes not denominated in EUR.

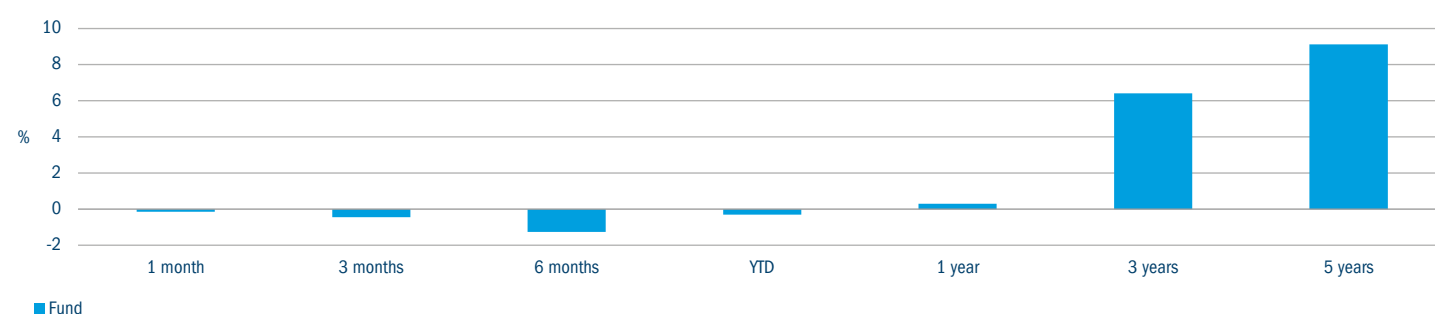
